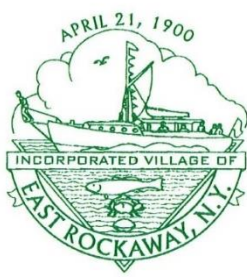

Under Chapter 134 of the Code of the Inc. Village of East Rockaway, effective June 1, 1997, if you own a piece of public assembly you must be licensed to do business. The following requirements are necessary to obtain a license. There are two classifications- Public Assembly or Public Assembly being used as a Cabaret or Dance Hall.

For the purposed of classification, the following definitions will serve as a guide line for classifying your establishment:

1. RESTAURANT or BAR – Any Place (except a catering establishment) in which food or drink is served to the public.
2. PLACE OF PUBLIC ASSEMBLY – Any place or space which is used for recreation, amusement, social, sports, religious, patriotic, civic, travel and similar purposes whether indoor or outdoor.
3. CABARET – Any place which provides in addition to food or drink, any form of live music or other amusement.
4. CATERING ESTABLISHMENT – Any place serving drink or food which is not generally open to the public and is designed for special function.
5. DANCE HALL – Any place in which dancing is carried on.

PUBLIC ASSEMBLY:

1. Application form entitled, “Public Assembly License Application” must be submitted along with the \$150.00 application fee.
2. Two professional type complete dimensioned floor layout with seating arrangement must be submitted with an application.
3. Applicants for a license for any premise which served alcohol or permits alcohol to be consumed must supply a current New York State Liquor Authority license (Please attach to application).

PUBLIC ASSEMBLY USED FOR CABARET and/or DANCE HALL:

Applicants must complete a separate application for a Dance-Cabaret-Entertainment License if the place of public assembly is to be used for entertainment or dancing.

FEE SCHEDULE FOR ALL PLACES OF PUBLIC ASSEMBLY:

PUBLIC ASSEMBLY LICENSE- \$150.00 per year.

CABARET/DANCING/PERFORMANCE LICENSE- \$100.00 per year.
